- Balance must be paid in full before mare departs or semen is shipped.** Mare must be picked up at the ranch immediately after mare is serviced and will no longer stand for the stud, unless prior arrangements have been made.
- Mare shall be in healthy and of sound breeding condition, as certified by veterinary examination prior to arrival at ranch or semen is shipped. Owner must have a breeding health certificate from a licensed veterinary at his/her own expense. It is also agreed that there will be a charge of \$100.00 for foaling mare out at ranch prior to service if needed.
- Mare must be halter broke and easy to handle. All board, veterinary, and other expenses must be paid before mare is allowed to leave ranch.
- Additional registration or membership fees with other associations other than AQHA is the responsibility of Mare owner. Bo is also registered as a breeding stallion with American Paint Horse Association (APHA) and Appaloosa Horse Club (ApHC).
- J / D Quarter Horses; Justin and Darlene Brunkhardt will care for mare and/or foal in a diligent manner, and reserves the right to employ veterinary care at owner's expense in case of illness or injury. Owner agrees that J / D Quarter Horses; Justin and Darlene Brunkhardt will not be responsible for accident, sickness or death to owner's mare and or/foal.
- J / D Quarter Horses; Justin and Darlene Brunkhardt, stallion owner guarantees a live foal from this mating, meaning the foal shall stand and suck within 24 hours. Should it not, owner will be entitled to a return privilege for one mare the following season only, no refund will be given for original breeding fee. If shipping semen the mare owner will be responsible for additional lab, chute, handling, and shipping fees associated to A.I. the mare. ***This guarantee will apply only if J / D Quarter Horses; Justin and Darlene Brunkhardt is notified within 48 hours of foal's death. Statement of details by a licensed veterinarian must follow within 10 days or guarantee becomes null and void.*** This clause is also binding in case of abortion.
- When stallion owner signs this contract to mare owner, it will then be a binding contract for both parties, subject to terms and conditions. This contract shall not be assigned or transferred by mare owner.
- Proof of current year's vaccination (rhino), EHV1 temp certification and Breeding Health Certificate Required prior to initial breeding or Rebreed will not be honored.
